SHARE PURCHASE PLAN CLOSING DATE EXTENDED AND BUSINESS UPDATE

Leading software technology communications company, **MGM Wireless Limited (ASX:MWR)** (“MGM” or “the Company”) advises that the closing date of the share purchase plan (SPP) announced on 5 June 2020, has been extended to 5:00 pm (Adelaide time) on Tuesday, 7 July 2020.

The Company has previously announced and provided updates, most recently on 11 June 2020, regarding the status of a significant customer contract. The Company will inform the market immediately once it is in a position to make an announcement about the customer contract outcome.

The MGM Board recognizes that an announcement about the customer contract outcome may be relevant to the SPP investment decision of some eligible shareholders. Extending the SPP closing date to a date currently anticipated to be after the outcome of the customer contract is announced, will provide those shareholders an opportunity to evaluate that information before deciding whether to participate in the SPP.

- By mail (for shareholders who have not registered to receive correspondence from the Company electronically).

Business update

As previously announced in April, SPACETALK sales have been subdued amid the COVID-19 pandemic. Company revenue has surpassed \$10 million (unaudited) for the 11 month period to 31 May 2020. Despite the COVID-19 interruption, monthly recurring revenue from AllMyTribe smartphone app subscriptions remains strong, continuing at an annualised rate of \$1.5 million.

The Company's balance sheet is strong, with \$3.7 million in cash at 31 May 2020. The Company is debt free, with the repayment of a \$1.75 million convertible note in May 2020.

Progress continues to be made towards improving retailer sell-through, expanding the Company's existing extensive distribution and launch of a high quality 4G wearable device for the seniors market will be announced in the coming days.
